## Summer 2025 Financial Aid Application Information

In order to be considered for financial aid for summer 2025, you must have a 2024-25 FAFSA on file with the Office of Financial Aid. In addition, we strongly encourage you to submit a Summer Aid Request Form by **April 15<sup>th</sup>** so that we are aware of your intent to register and can process an aid package prior to your billing due date. **Please allow 2 weeks for processing/review.**

**Summer aid is contingent upon funding availability and is not guaranteed.**

Summer aid is often limited to loans, and in some cases, Federal Pell Grant eligibility. Not all students qualify – for example, students who have already borrowed the maximum loan eligibility for the academic year, or students who will be enrolled less than half-time are ineligible for loans.

Pell-eligible students may be eligible for a pro-rated summer Pell award based on the number of credits in which the student is enrolled. CNU is proud to offer a summer scholarship opportunity for Pell-eligible students to assist with tuition and fees, summer housing, and/or a summer meal plan. Students must submit this application to be considered for the scholarship.

**All students must be enrolled at least half-time per federal guidelines in order to receive aid** (6 credits minimum undergraduate, 3 credits graduate). Audit classes do not count.

If you have exhausted your federal student aid eligibility during the fall/spring semesters, you may want to consider the Direct Parent PLUS Loan or a private education loan.

In order to receive summer aid, a student must be in a degree-seeking program at CNU.

**Disbursement Schedule:** Award funds will not be disbursed until the beginning of the term that brings your total summer enrollment to half-time. For example, if you enroll in Term 1 for 3 hours and Term 2 for 3 hours, funds will not be disbursed until the beginning of Term 2. Loans will be disbursed **no earlier** than:

**May Term: May 13, 2025**

**Term 1: June 3, 2025**

**Term 2: July 10, 2025**

(Note: These dates are approximate.)

Students will be notified of tentative summer aid eligibility via email, and must view and accept/decline award offers via CNU Live.

Tentative eligibility is based on anticipated enrollment. Enrollment for fewer credit hours than anticipated at the time of eligibility review will result in reduction or cancellation of aid.

Do not assume you are receiving financial aid until you have received an aid offer AND you have submitted/completed all documents needed to process your aid. Students will be notified via email if ineligible for summer aid.
